More about FEMA's Risk MAP program and Discovery is further described below.

Why Discovery?

The data that FEMA has available only tells part of the story. For a more complete picture of a community's risk, FEMA relies heavily on information and data provided by the community itself. More than that, you know your community better than anyone. We look to you for input on where to focus efforts as we work together to assess risk and plan mitigation activities to build a stronger, safer, and more resilient community. Once communities provide FEMA with local flood risk and other data, NYSDEC/FEMA schedules a Discovery Meeting.

Why Participate?

The Risk MAP efforts can take between 3-7 years; participation throughout this process is crucial to ensure the most accurate information is informing the final products. Key members that are encouraged to attend the meeting include, but are not limited to community and Tribal officials, including leaders, floodplain administrators, engineers, watershed council representatives, planners, public works officials, emergency managers, transportation staff, and GIS specialists.

Discovery Meeting Goals:

- Review and validate flood and other hazard data, event history, development plans, mapping needs, and local risk concerns;
- Identify risk assessment tools available through FEMA's Risk MAP program to enhance current resilience efforts;
- Prioritize areas of future study, planning, and mitigation needs;
- Strategize on mitigation opportunities, projects, educational needs; and
- Collaborate across local, State, and Federal agencies.
